Christoph Junge is Chief Financial Officer (CFO) of UNITY Management GmbH and a member of the management. The company is the parent organisation of the management consultancy UNITY AG, Büren, with the aim, among others, of driving its inorganic growth. In his role, Junge is responsible for finance and M&A for the rapidly expanding group of companies. Previously, the graduate industrial engineer also held finance positions at other companies, including Group CFO of Telio BidCo Germany GmbH from 2024 to 2025, Group CFO of netgo GmbH from 2020 to 2021, and a member of the Executive Board (CFO) of adesso SE and its predecessor companies from 2005 to 2019. From 2021 to 2024, as Head of Corporate Development with power of attorney, he was responsible for strategic initiatives in internationalisation and M&A at adesso. He began his professional career after completing his studies in Hamburg as an M&A consultant.
